ACCEPTING AND APPROPRIATING GRANT FUNDS FROM ALASKA DEPARTMENT OF NATURAL RESOURCES AND APPROPRIATING MATCHING MONIES FROM THE NORTH PENINSULA RECREATION SERVICE AREA.

WHEREAS, the Mayor was authorized to apply for a Federal Land and Water Conservation Fund Grant through the Alaska Department of Natural Resources by Resolution 86-163 to develop a hiking/cross-country ski trail system within the North Peninsula Recreation Service Area; and

WHEREAS, notice has been received that the grant has been approved; and

WHEREAS, matching monies were appropriated in the North Peninsula Recreation Service Area budget for fiscal year 1988 but need to be transferred to the Capital Projects Fund; and

WHEREAS, the remainder of the matching monies are available in the unappropriated fund balance of the North Peninsula Recreation Service Area but must be transferred to the Capital Projects Fund:

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- Section 1. That the Mayor is authorized to accept and execute the provisions of the Federal Land and Water Conservation Fund Grant in the amount of \$131,285.22.
- Section 2. That the sum of \$131,285.22 is appropriated in the North Peninsula Recreation Service Area Capital Projects Fund 459.611010.49999.02332 in accordance with grant conditions.
- Section 3. That the sum of \$80,300 appropriated in the North Peninsula Recreation Service Area budget 225.611010.49997 Grant Matching Monies be transferred to and appropriated in the North Peninsula Recreation Service Area Capital Projects Fund 459.611010.49999.02332 as part of the matching money for this grant.
- Section 4. That the remaining matching monies of \$50,985.22 be appropriated from the fund balance of the North Peninsula Recreation Service Area 225.27910 and transferred to and appropriated in the North Peninsula Recreation Service Area Capital Projects Fund 459.611010.49999.02332.
