MAKING APPROPRIATIONS TO THE SERVICE AREAS IN THE BOROUGH FOR FISCAL YEAR 1988-89.

NOW THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- Section 1. That \$2,212,019 is appropriated to the Nikiski Fire Service Area fund for operations for the fiscal year July 1, 1988, through June 30, 1989.
- Section 2. That \$80,761 is appropriated to the Bear Creek Fire Service Area fund for operations for the fiscal year July 1, 1988, through June 30, 1989.
- Section 3. That \$713,176 is appropriated to the Ridgeway/ Sterling Fire Service Area fund for operations for the fiscal year July 1, 1988, through June 30, 1989.
- Section 4. That \$85,923 is appropriated to the Anchor Point Fire and Emergency Medical Service Area fund for operations for the fiscal year July 1, 1988, through June 30, 1989.
- Section 5. That \$401,705 is appropriated to the Kalifornsky Fire Service Area fund for operations for the fiscal year July 1, 1988, through June 30, 1989.
- Section 6. That \$864,583 is appropriated to the Central Peninsula Emergency Medical Service Area fund for operations for the fiscal year July 1, 1988, through June 30, 1989.

- Section 7. That \$568,473 is appropriated to the North Peninsula Recreation Service Area fund for operations for the fiscal year July 1, 1988, through June 30, 1989.
- Section 8. That \$241,139 is appropriated to the North Kenai Peninsula Road Maintenance Service Area fund for operations for the fiscal year July 1, 1988, through June 30, 1989.
- Section 9. That \$344,774 is appropriated to the South Kenai Peninsula Road Maintenance Service Area fund for operations for the fiscal year July 1, 1988, through June 30, 1989.
- Section 10. That \$56,313 is appropriated to the East Kenai Peninsula Road Maintenance Service Area fund for operations for the fiscal year July 1, 1988, through June 30, 1989.
- Section 11. That \$561,140 is appropriated to the Central Kenai Peninsula Road Maintenance Service Area fund for operations for the fiscal year July 1, 1988, through June 30, 1989.
- Section 12. That \$3,261,208 is appropriated to the Central Kenai Peninsula Hospital Service Area fund for operations for the fiscal year July 1, 1988, through June 30, 1989.
- Section 13. That \$1,488,739 is appropriated to the South Peninsula Hospital Service Area fund for operations for the fiscal year July 1, 1988, through June 30, 1989.
