**KENAI PENINSULA BOROUGH  
ORDINANCE 92-06**

**AN ORDINANCE APPROPRIATING AN ADDITIONAL \$39,058 AND  
AUTHORIZING THE PURCHASE OF A TANKER PUMPER FOR THE BEAR  
CREEK FIRE SERVICE AREA**

**WHEREAS,** the Bear Creek Fire Service Area has need for a tanker pumper; and

**WHEREAS,** there is a grant from the Alaska Department of Administration in the amount of \$100,000 appropriated on Ordinance 91-39 for this purpose; and

**WHEREAS,** there is \$15,175 currently appropriated in the capital projects fund; and

**WHEREAS,** there is \$29,058 available in the capital projects unappropriated fund balance; and

**WHEREAS,** the Bear Creek volunteer organization is contributing \$6,000 toward the purchase of this tanker pumper; and

**WHEREAS,** there is \$4,000 that can be transferred from the Bear Creek Fire Service operations budget to the capital projects budget; and

**WHEREAS,** bids have been requested and received by the Finance Department for this tanker pumper; and

**WHEREAS,** the Bear Creek Fire Service Area Board has accepted the bid of Becker Fire Equipment Co. in the amount of \$154,233;

**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**Section 1.** That the Mayor is authorized to purchase a tanker pumper in the amount of \$154,233 from Becker Fire Equipment Co. on behalf of the Bear Creek Fire Service Area.


**Section 2.** That the amount of \$29,058 be appropriated from the Bear Creek Fire Service Area capital projects fund balance to account number 442.521010.48310.92961.

**Section 3.** That the \$6,000 donation from the Bear Creek volunteer association be appropriated to account number 442.521010.48310.92961 for the purchase of this tanker pumper.


**Section 4.** That the Bear Creek Fire Service Area budget for firefighting equipment be revised to reflect an additional \$4,000 transfer to the capital projects fund and that this transfer be appropriated in account number 442.521010.48310.92961.

**Section 5.** That this ordinance takes effect immediately upon its enactment.
