**KENAI PENINSULA BOROUGH
ORDINANCE 92-46**

**AN ORDINANCE AUTHORIZING THE RECEIPT OF STATE GRANTS FOR
VARIOUS LIBRARIES THROUGHOUT THE BOROUGH AND APPROPRIATING
\$65,000 OF GRANT FUNDS**

WHEREAS, the State of Alaska has appropriated \$65,000 for grants to the Kenai Peninsula Borough for various libraries throughout the Borough; and

WHEREAS, \$10,000 is allocated for Anchor Point Library acquisitions; and

WHEREAS, \$10,000 is allocated for Homer Library acquisitions; and

WHEREAS, \$5,000 is allocated for Hope Library supplies and equipment; and

WHEREAS, \$10,000 is allocated for Kenai Library repairs and acquisitions; and

WHEREAS, \$10,000 is allocated for Ninilchik Library acquisitions; and

WHEREAS, \$10,000 is allocated for Seldovia Library acquisitions; and

WHEREAS, \$10,000 is allocated for Soldotna Library acquisitions;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That the Mayor is authorized to accept these grants as a pass-through agency on behalf of various libraries throughout the borough in the total amount of \$65,000 appropriated by the Alaska Legislature in Chapter 5 SLA 1992.

SECTION 2. That the Mayor is authorized to execute any agreements necessary to accept and distribute these grant funds.


SECTION 3. That these grant funds are appropriated to the following borough accounts:


SECTION 4. That these grant funds shall be utilized to carry out the purposes of the grant, under the terms and conditions specified in the grant agreement.
