## KENAI PENINSULA BOROUGH ORDINANCE 93-16

## AN ORDINANCE APPROPRIATING \$506,570 FOR SCHOOL AND SOLID WASTE LANDFILL CAPITAL PROJECTS

- WHEREAS, the FY 1993-94 budget appropriation will not become effective until July 1, 1993; and
- WHEREAS, the gymnasium floors at Skyview High School and Nikiski High School are currently closed because they are unsafe; and
- WHEREAS, the KPB School Board desires to have the gymnasium floors in usable condition by next school year, it is necessary to appropriate funds ahead of the normal budget schedule; and
- WHEREAS, the propane tank and piping are in need of replacement at the English Bay School; and
- WHEREAS, the Nanwalek landfill is in need of various processing equipment and site improvements; and
- WHEREAS, closure of the existing landfill at Tyonek needs to be done when the new site becomes operational; and funding needs to be provided for contract administration for all Tyonek capital projects; and
- WHEREAS, the Seldovia Landfill needs three monitor wells installed, along with the well inventory, survey sampling, analysis, and report preparation; installation of a cutoff wall along the dike to prevent infiltration of surface water, grading and other
  drainage improvements; installation of site fencing, gates and signs to restrict
  access; and to provide funding for contract administration of all Seldovia capital
  projects; and
- WHEREAS, the Homer Baling facility needs the installation of two monitor wells, along with the well inventory, survey sampling, analysis, and report preparation; and to provide funding for contact administration for all Homer capital projects; and
- WHEREAS, the Sterling Special Waste Site needs the installation of slope stabilization

material, topsoil, seeding and other erosion control/corrective measures performed; and to provide funding for contract administration for all Sterling projects;

## NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- **SECTION 1.** That \$150,000 be appropriated from the general fund fund balance to account number 400-710802-49999-93107 for the replacement of the Nikiski High School gymnasium floor.
- **SECTION 2.** That \$150,000 be appropriated from the general fund fund balance to account number 400-711800-49999-93108 for the replacement of the Skyview High School gymnasium floor.
- **SECTION 3.** That \$30,000 be appropriated from the general fund fund balance to account number 400-710300-49999-93109 for the replacement of the piping and propane tank at English Bay School.
- SECTION 4. That\$77,570 be appropriated from the general fund fund balance to the Seldovia Landfill account number 411-321040-49999-93110 for installation of three monitor wells; installation of a cut-off wall; installation of access restriction measures; and contract administration for all Seldovia capital projects.
- **SECTION 5.** That \$20,000 be appropriated from the general fund fund balance to the Homer Baling Facility account number 411-323010-49999-93111 for the installation of 2 monitor wells, \$14,400; and contract administration for all Homer capital projects.
- **SECTION 6.** That \$22,000 be appropriated from the general fund fund balance to the Sterling Special Waste Site account number 411-325010-49999-93112 for the installation of slope stabilization materials and other erosion control/corrective measures; and contract administration for all Sterling projects.
- SECTION 7. That \$30,000 be appropriated from the general fund fund balance to the Tyonek Landfill account number 411-321080-49999-93113 for the closure of the existing landfill at Tyonek and to provide funding for contract administration for all Tyonek projects.
- **SECTION 8.** That \$27,000 be appropriated from the general fund fund balance to account number 411-321060-49999-93114 for the equipment purchases and site improvements at the village of Nanwalek.
- **SECTION 9.** That this ordinance takes effect immediately upon its enactment.
