**KENAI PENINSULA BOROUGH
ORDINANCE 93-20**

**AN ORDINANCE APPROPRIATING FUNDS FOR TRANSPORTATION PLANNING
FOR IMPLEMENTATION OF THE ISTE A PROGRAM**

WHEREAS, the U.S. Congress has enacted the Intermodal Surface Transportation Efficiency Act which calls for a portion of federal highway funds to be used on local roads; and

WHEREAS, the State of Alaska will receive funds that can be used on local road projects; and

WHEREAS, the Borough must develop a transportation plan in order to make recommendations for the use of these funds for roads with the Kenai Peninsula Borough and the cities within the Borough; and

WHEREAS, the Assembly by previous resolution established a transportation planning program for this purpose; and

WHEREAS, the State of Alaska has authorized a grant for \$104,000 for reimbursement to the Borough for expenses connected with the planning process and development of a program for future planning; and

WHEREAS, these funds, together with \$6,000 from the Borough general fund for contingency, need to be appropriated;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That \$104,000 is hereby appropriated for the purpose of transportation planning from funds received from the State of Alaska, and \$6,000 is appropriated from the general fund balance to the following account numbers:


