AN ORDINANCE APPROPRIATING FUNDS FOR FISCAL YEAR 1993-94

WHEREAS, Alaska Statutes 29.35.100 and the Borough Code of Ordinances 05.04.020 require the Mayor to present a budget proposal for the fiscal year 1993-1994; and

whereas, the Assembly is empowered with making appropriations for the General Fund, the Special Revenue Funds, the Debt Service Funds, the Capital Projects Funds, the Enterprise Funds, and the Internal Service Funds of the Borough; and

WHEREAS, appropriations in the amount of \$26,195,416 have been made through Ordinance 93-19 to the school district (and therefore have not been included in this ordinance) in the following areas;
