**KENAI PENINSULA BOROUGH  
ORDINANCE 93-44**

**AN ORDINANCE ACCEPTING AND APPROPRIATING  
A SECTION 309 ENHANCEMENT GRANT FROM  
THE STATE OF ALASKA FOR THE KENAI PENINSULA BOROUGH  
COASTAL MANAGEMENT PROGRAM**

**WHEREAS,** the Kenai River system supports the largest recreational fishery in Alaska and is a major contributor to the commercial sockeye salmon and chinook salmon catches in Cook Inlet; and

**WHEREAS,** the Alaska Department of Community and Regional Affairs has approved the Alaska Department of Fish and Game, Division of Habitat request for funding under Section 309 Enhancement Grant Program of the Alaska Coastal Management Program; and

**WHEREAS,** the Kenai Peninsula Borough has been awarded \$29,500 for use in a joint project by the Alaska Department of Fish and Game and the Kenai Peninsula Borough Coastal Management Program for assessment and control of cumulative impacts of coastal uses on fish habitat of the Kenai River

**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** That the Kenai Peninsula Borough Assembly hereby accepts a grant of \$29,500 from the State of Alaska to fund the Kenai Peninsula Borough Coastal Management Program required tasks of the Section 309 Enhancement Grant Program.

**SECTION 2.** That the sum of \$29,500 is hereby appropriated to the following accounts in these respective amounts:


**SECTION 3.** That these funds shall be utilized to carry out the required tasks and special projects of the grant.
