**KENAI PENINSULA BOROUGH
ORDINANCE 93-52**

**AN ORDINANCE AUTHORIZING THE RECEIPT OF STATE GRANTS IN THE
AMOUNT OF \$620,700 AND APPROPRIATING
\$266,100 FOR SCHOOL CAPITAL PROJECTS**

WHEREAS, the legislature, through passage of Senate Bill 7 during the 1993 legislative session, established a major maintenance matching grant program for funding school maintenance projects; and

WHEREAS, funding under this program will be on a percentage-share basis between the State and the local municipality; and

WHEREAS, the local share requirement is based on the taxable value of real and personal property and, following the required formula, the Borough's local share percentage is 30%; and

WHEREAS, Senate Bill 60, passed during the 1993 legislative session, appropriated \$620,700 as the State's 70% share of various school projects within the Kenai Peninsula Borough; and

WHEREAS, the Assembly is required to appropriate both the State's 70% share and the local 30% share; and

WHEREAS, the Kenai Peninsula Borough deems it in the best interest of the public to participate in the State's major maintenance matching grant program;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That the Mayor is authorized to accept grants for various school maintenance projects in the total amount of \$620,700 as appropriated by the Alaska Legislature in Chapter 83, SLA 1993.

SECTION 2. That \$266,100 is appropriated from the Borough's General Fund Balance as the Borough's 30% matching share.

SECTION 3. That the State's 70% share and the Borough's 30% share are appropriated for the following projects:


