**KENAI PENINSULA BOROUGH  
ORDINANCE 94-22**

**AN ORDINANCE AMENDING THE PROCEDURE FOR FILLING VACANCIES ON  
THE NIKISKI FIRE SERVICE AREA AND THE NIKISKI SENIOR  
SERVICE AREA BOARDS**

**WHEREAS**, Ordinance 93-29, Amending the Nikiski Fire Service Area Ordinance, was adopted by the Kenai Peninsula Borough Assembly on July 13, 1993; and

**WHEREAS**, Ordinance 93-29 established a new procedure for filling vacancies on the board of the Nikiski Fire Service Area; and

**WHEREAS**, this procedure allows the remaining board members to appoint a replacement to serve until the term expires; and

**WHEREAS**, other elected service area boards appoint a replacement to serve only until the next regular election; and

**WHEREAS**, Ordinance 93-05, Creating the Nikiski Senior Service Area, adopted by the Assembly on February 16, 1993, contained no provision for filling a vacancy on the service area board; and

**WHEREAS**, for reasons of continuity, the procedures should be the same for all service areas;

**NOW, THEREFORE, BE IT ORDAINED BY THE KENAI PENINSULA BOROUGH ASSEMBLY:**

**SECTION 1.** That Section 16.12.070 of the Nikiski Fire Service Area shall be amended as follows:

**16.12.070. Board vacancies - Filling.**

Vacancies on the board shall be filled by majority vote of the remaining board until the next regular election of the borough at which a new member shall be elected to fill the unexpired term or for a 3-year term if no unexpired term remains [FOR THE REMAINDER OF THE TERM].

**SECTION 2.** That a new Section 16.70.070(B) is added to the Nikiski Senior Service Area to read:


**16.70.070. Board - Vacancies created when - Filling vacancies.**

B. Vacancies on the board shall be filled by majority vote of the remaining board until the next regular election of the borough at which time a new member shall be elected to fill the unexpired term or for a 3-year term if no unexpired term remains.

**SECTION 3.** That this ordinance shall take effect upon enactment.
