KENAI PENINSULA BOROUGH ORDINANCE 95-14

AN ORDINANCE APPROPRIATING FUNDS FOR SCHOOL PURPOSES FOR FISCAL YEAR 1995-96

- WHEREAS, the Assembly is required by Alaska Statute 14.14.060(c) to make an appropriation for the local share of funding for the school budget by May 31; and
- WHEREAS, Resolution 95-021 approved a total school budget of \$81,792,518 and established that up to \$27,466,567 be provided from local sources (\$21,532,455 local effort and \$5,934,112 in-kind services) for school purposes; and
- WHEREAS, the Assembly desires to adopt a capital budget for major maintenance items to extend the life of existing facilities;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That subject to the provisions of this ordinance, the following is appropriated to the school fund from local sources for school operations purposes and in-kind services for the year July 1, 1995 through June 30, 1996:

- **SECTION 2.** That disbursements from the direct appropriation in Section 1 item (A) shall be made only as needed to supplement other revenues available and received by the school district to fund the school district operations portion of the budget of \$76,265,488.
- **SECTION 3.** That \$1,750,000 is appropriated in the General Fund for the fiscal year beginning July 1, 1995, and ending June 30, 1996.
