KENAI PENINSULA BOROUGH ORDINANCE 95-27

AN ORDINANCE AUTHORIZING THE RECEIPT OF A MUNICIPAL CAPITAL MATCHING GRANT FROM THE STATE OF ALASKA FOR ROAD PROJECTS; AND APPROPRIATING \$655,587 TO CAPITAL PROJECTS ACCOUNTS

- WHEREAS, funding in the amount of \$18.3 million was appropriated by the State Legislature for the fiscal year 1995-1996 municipal capital project matching grant program; and
- WHEREAS, the Borough has been notified by the State Department of Administration of its eligibility to receive a grant in fiscal year 1995-1996 through the municipal capital matching grant program for the purpose of a road improvement program, and that the allocation to the Borough for this project is \$655,587; and
- WHEREAS, for each capital project grant that a municipality receives in the program, a local match, or local share of the cost, must be provided by the municipality; and
- WHEREAS, a local share requirement is based on the population of a municipality and, following the required formula, the Borough's local share percentage is 30%, or \$280,966; and
- WHEREAS, matching funds from the Road Service Area were appropriated through enactment of Ordinance 95-17 on June 6, 1995; and
- WHEREAS, a mill rate of .15 was levied on all taxable property within the Road Service Area and will be used to provide the necessary matching grant funds; and
- WHEREAS, funds in the amount of \$280,966 are available in the Road Service Area account No. 236-339051-49997 (road improvements and upgrades, matching grant monies); and
- WHEREAS, the local share contribution of \$280,966 and the State's allocation of \$655,587 will provide a total of \$936,553 to be used for road improvements on Borough-maintained roads; and
- WHEREAS, through adoption of Resolution 94-74 the Borough Assembly approved the list of roads projects for inclusion in the State's capital matching grant program for fiscal year 1995-1996;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- SECTION 1. That the Mayor is authorized to execute a grant agreement, thereby accepting the provisions therein, and to accept a state grant for capital improvement projects in the total amount of \$655,587 as appropriated by the Alaska Legislature.
- SECTION 2. That state grant funds in the amount of \$655,587 are appropriated to the following account: 434-339050-49999.M5896, Road Service Area Capital Projects Fund.
- **SECTION 3.** That local match requirements will be satisfied through local tax sources, and that \$280,966 will be transferred from account No. 236-339051-49997 to account No. 434-339050-49999.M5896.

SECTION 4. That this ordinance takes effect immediately upon its enactment.
