**KENAI PENINSULA BOROUGH  
ORDINANCE 96-09**

**AN ORDINANCE ACCEPTING AND APPROPRIATING A GRANT FROM  
THE STATE OF ALASKA FOR THE KENAI PENINSULA BOROUGH  
COASTAL MANAGEMENT PROGRAM**

**WHEREAS,** the Kenai Peninsula Borough Coastal Management Program provides local participation and guidance to State and federal agencies involved in developing projects, issuing permits, or managing land or resources within the coastal boundary of the Borough; and

**WHEREAS,** the Coastal Management Program also provides an information base and policies to assist the Borough in managing Borough land and making local decisions affecting coastal resources; and

**WHEREAS,** the Alaska Department of Community and Regional Affairs has approved the Borough's request for midyear funding under the Alaska Coastal Management Program; and

**WHEREAS,** the Kenai Peninsula Borough has been awarded \$10,000.00 for use in updating maps and printing of the Kenai Peninsula Borough Coastal Management Plan;

**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** That the Kenai Peninsula Borough Assembly hereby accepts a matching grant of \$10,000.00 from the State of Alaska for updating and printing the Kenai Peninsula Borough Coastal Management Program. The match required from the borough is 25%.

**SECTION 2.** That the sum of \$10,000.00 is hereby appropriated to the following accounts in these respective amounts:


