**KENAI PENINSULA BOROUGH  
ORDINANCE 96-20**

**AN ORDINANCE AMENDING KPC 22.40.080, AGENDA - ORDER OF BUSINESS**

**WHEREAS,** the official record of the meetings of the Kenai Peninsula Borough Assembly are the tape recordings of the proceedings made by the Borough Clerk; and

**WHEREAS,** the written minutes of the meetings are actually a summary of what occurred at the meeting, and not the official record of the meeting; and

**WHEREAS,** it takes an inordinate amount of Assembly meeting time to correct the written "minutes", and in fact, the amended "minutes" do not change what actually happened, was recorded and what is the official record of the meeting; and

**WHEREAS,** Resolution 95-065 requires the Borough Clerk to retain the audio tape records permanently; and

**WHEREAS,** valuable Assembly meeting time could be better used working on the business of the Borough;

**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** That KPB 22.40.080 is amended to read:

**22.40.080 Agenda - Order of business.**

The order of business shall be:

- A. Call to order;
- B. Pledge of allegiance;
- can. Invocation;
- D. Roll call;
- E. Vacancy, designation or seating members (only when needed);
- for. Approval of agenda and consent agenda;
- [G. APPROVAL OF MINUTES;]
- G[H]. Public comments and presentations (items other than those appearing on the agenda)  
(Limited to 20 minutes total);
- H[I]. Committee reports;

- I[J]. Reports of commissions and councils;
- J[K]. Items not completed from prior agenda;
- K[L]. Public hearings on ordinances (Testimony limited to 3 minutes per speaker);
- L[M]. Unfinished business
  - 1. Postponed items
  - 2. Notices to reconsider/rescind;
- M[N]. New business;
  - 1. Bid awards
  - 2. Resolutions
  - 3. Ordinances for introduction
  - 4. Other (including addition of late items);
- N[O]. Public comments and public presentations (Limited to 3 minutes per speaker);
- O[P]. Mayor's report;
- P[Q]. Assembly meeting and hearing announcements;
- Q[R]. Assembly comments;
- R[S]. Pending legislation;
- S[T]. Informational materials and reports;
- T[U]. Notice of the next meeting and adjournment.

**SECTION 2.** That this ordinance shall take effect upon enactment.
