KENAI PENINSULA BOROUGH ORDINANCE 97-22

AN ORDINANCE AMENDING THE TAX CODE TO CREATE AN EXEMPTION FROM TAXATION FOR THE ASSESSED VALUE OF BOATS AND AIRCRAFT IN EXCESS OF \$100,000

- WHEREAS, public testimony received during the recent hearings on Ordinance 96-47 indicated that some boat owners removed their boats from the Kenai Peninsula Borough to avoid what was perceived as excessive taxes; and
- WHEREAS, exempting from taxation the assessed value of these boats in excess of \$100,000 should encourage these boat owners to have home ports within the Borough again because their tax liability would be reduced; and
- WHEREAS, though the taxable value of existing boats within the Borough would decrease by approximately \$13,036,069 as a result of this ordinance being adopted, the potential increase in taxable value as a result of new filings by those selecting ports within the Borough as their home port may offset this decrease and possibly even increase taxable value; and
- WHEREAS, Alaska Statute 29.45.050(b)(2) authorizes a municipality to exempt or partially exempt some or all types of personal property such as boats and aircraft from ad valorem taxes; and
- WHEREAS, other economic benefits to the Borough's residents both outside and inside cities could result from an increase in business activity brought about by more boats

choosing a port within the Borough as their home port; and

WHEREAS, encouraging economic development within the Borough outside of cities is a goal of the Borough Assembly recently codified at KPB 19.30.040;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That KPB 5.12.135 is enacted to read as follows:

5.12.125. Personal property tax — Exemptions — boat and aircraft value over \$100,000. In addition to exemptions required by law, the assessed value of all boats and aircraft located within the Kenai Peninsula Borough in excess of \$100,000 is exempt from the Borough tax levy on personal property within the Borough.

SECTION 2. That section 1 of this ordinance shall take effect January 1, 1998.
