**KENAI PENINSULA BOROUGH
ORDINANCE 97-30**

**AN ORDINANCE AUTHORIZING THE RECEIPT OF A MUNICIPAL CAPITAL
MATCHING GRANT FROM THE STATE OF ALASKA FOR OXYGEN SYSTEM
UPGRADES AT SOUTH PENINSULA HOSPITAL**

- WHEREAS,** the Borough has been notified by the State Department of Administration of its eligibility to receive a grant through the municipal capital matching grant program for the purpose of an oxygen system upgrade for South Peninsula Hospital Service Area, and the allocation to the Borough for this project is \$17,183; and
- WHEREAS,** for each capital project grant that a municipality receives in the program, a local match, or local share of the cost, must be provided by the municipality; and
- WHEREAS,** a local share requirement is based on the population of a municipality and, following the required formula, the Service Area's share percentage is 30%; and
- WHEREAS,** the South Peninsula Hospital Service Area Board has approved use of local funds (tax revenues) in the amount of \$3,198 to satisfy the necessary matching requirements; and
- WHEREAS,** funds in the amount of \$3,198 are available in the South Peninsula Hospital Service Area contingency account; and
- WHEREAS,** the local share contribution of \$3,198 and the State's allocation of \$7,463 will provide a total of \$10,661 for the purchase and installation of equipment for their oxygen supply system; and
- WHEREAS,** through adoption of Resolution 93-117 the Borough Assembly approved this project for inclusion in the State's FY'95 capital matching grant program;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. The Mayor is authorized to execute a grant agreement, thereby accepting the provisions therein, and to accept a grant for a capital improvement project to upgrade the oxygen system at South Peninsula Hospital in the total amount of \$7,463 as appropriated by the Alaska Legislature.

SECTION 2. that grant funds in the amount of \$7,463 are appropriated to the South Peninsula Hospital Service Area Capital Projects Fund.

SECTION 3. That local match requirements will be satisfied through local tax sources, and that \$3,198 will be transferred from account No. 601-812010-49999 (Contingency) to account No. 601-812011-49999-M5883 (Capital Projects).


SECTION 4. That this ordinance takes effect immediately upon its enactment.
