**KENAI PENINSULA BOROUGH  
ORDINANCE 99-18**

**AN ORDINANCE AMENDING KPB 5.04.021 TO ELIMINATE THE REQUIREMENT THAT THE ORDINANCE APPROPRIATING FUNDS FOR THE SCHOOL DISTRICT BE HEARD WITHIN 30 DAYS AFTER RECEIPT OF THE SCHOOL BUDGET AND DELETING THE PROVISION THAT THE STATEMENT OF THE SUM TO BE MADE AVAILABLE FOR SCHOOL PURPOSES IS NOT BINDING UNTIL THERE IS AN APPROPRIATING ORDINANCE**

**WHEREAS,** AS 14.14.060(c) requires the assembly to furnish the school board with a statement of the sum to be made available for school purposes from local sources within 30 days after receipt of the school district budget; and

**WHEREAS,** AS 14.14.060(c) also requires that the school board submit its school budget for the following school year to the borough assembly by May 1 for approval of the total amount and requires the assembly to appropriate the amount to be made available from local sources by June 30, except that the May 1 and June 30 deadlines may be modified by municipal ordinance; and

**WHEREAS,** KPB 5.04.021 requires the assembly to pass the appropriating ordinance within 30 days after receipt of the school budget which is half of the time allowed by state statute for consideration of the school budget;

**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** That KPB 5.04.021 is hereby amended to read as follows:


**5.04.021. Budget proposal — School district — Appropriation from local sources.**

An appropriation ordinance to provide the amount to be made available from local sources for school purposes in the borough school district shall be introduced in the assembly [ON OR ABOUT THE TIME THAT THE BOROUGH SCHOOL BOARD SUBMITS THE SCHOOL BUDGET TO THE BOROUGH ASSEMBLY IN ORDER THAT THE PUBLIC HEARING ON THE ORDINANCE MAY BE HELD WITHIN 30 DAYS AFTER RECEIPT OF THE SCHOOL BUDGET.] 25 days or more before the last assembly meeting scheduled before June 15th each year. The statement of the sum to be made available


for school purposes from local sources [MAY NOT BE MADE AS A BINDING OBLIGATION OF THE BOROUGH UNLESS AND UNTIL THERE IS AN APPROPRIATION ORDINANCE, DULY ENACTED, SETTING FORTH THE TOTAL AMOUNT OF MONEY TO BE MADE AVAILABLE FROM LOCAL SOURCES FOR SCHOOL PURPOSES DURING THE NEXT FISCAL YEAR.] as required by AS 14.14.060(c) shall be furnished to the school board within 30 days after receipt of the budget by the assembly.

**SECTION 2.** That this ordinance shall take effect immediately upon its enactment.
