**KENAI PENINSULA BOROUGH  
ORDINANCE 99-21**

**AN ORDINANCE AMENDING KPB 22.40.080 TO ALLOW THE READING  
OF PROCLAMATIONS AND COMMENDING RESOLUTIONS EARLY IN  
THE ASSEMBLY MEETING**

**WHEREAS**, commending resolutions are currently listed under agenda item “M” and are approved as a part of the Consent Agenda; and

**WHEREAS**, it is more appropriate to provide a place on the regular agenda for the reading of proclamations of the Mayor and commending resolutions early in the meeting to allow those being recognized to receive their commendations before the regular business of the Assembly is taken up;

**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** KPB 22.40.080 is hereby amended as follows:

**22.40.080. Agenda — Order of business.**


The order of business shall be:

- B. Pledge of allegiance;
- C. Invocation;
- D. Roll call;
- E. Vacancy, designation or seating members (only when needed);
- F. Approval of agenda and consent agenda;
- G. Commending Resolutions and Proclamations
- [G]H. Public comments and presentations (items other than those appearing on the agenda) (Limited to 20 minutes total);
- [H]I. Committee reports;
- [I] J. Reports of commissions and councils;
- [J] K. Mayor’s Report
- [K]L. Items not completed from prior agenda;
- [L]M. Public hearings on ordinances (Testimony limited to 3 minutes per speaker);
- [M]N. Unfinished business
  - 1. Postponed items


- 2. Notices to reconsider/rescind;
- [N]Q. New business;
  - 1. Bid awards
  - 2. Resolutions
  - 3. Ordinances for introduction
  - 4. Other (including addition of late items);
- [O]P. Public comments and public presentations (Limited to 3 minutes per speaker);
- [P]Q. Assembly meeting and hearing announcements;
- [Q]R. Assembly comments;
- [R]S. Pending legislation;
- [S]T. Informational materials and reports;
- [T]U. Notice of the next meeting and adjournment.

**SECTION 2.** That this ordinance shall take effect immediately upon its enactment.
