KENAI PENINSULA BOROUGH ORDINANCE 99-23

AN ORDINANCE APPROPRIATING \$450,000 IN UNRESERVED RETAINED EARNINGS FROM THE SOUTH PENINSULA HOSPITAL FUND FOR REMOVAL OF AN UNDERGROUND STORAGE TANK, INSTALLATION OF A NEW ABOVE GROUND TANK, SITE REMEDIATION, AND ASSOCIATED STRUCTURAL AND CIVIL WORK AT THE SOUTH PENINSULA

- WHEREAS, on January 12, 1999 South Peninsula Hospital (SPH) received a Compliance Order By Consent (COBC Number UST-99-460) from the Alaska State Attorney General indicating that the borough had not closed or upgraded an underground storage tank (UST) located at SPH as required by state and federal law; and
- WHEREAS, acceptance of the COBC would resolve the violation of state and federal law and extend the deadline to close or upgrade the UST to March 1, 1999; and
- WHEREAS, the Kenai Peninsula Borough signed the order accepting its provisions; and
- WHEREAS, SPH received an extension of the deadline to March 16, 1999 and partially complied with the COBC by closing the tank prior to that date; and
- WHEREAS, it is now necessary to remove the tank, remediate the site, install an above ground replacement tank, and complete associated construction work in order to fully comply with the COBC; and
- WHEREAS, it is necessary to complete the UST project prior to start of the SPH expansion project expected to begin later this summer; and
- WHEREAS, sufficient funds are available in the SPH Enterprise Fund unreserved retained earnings account to complete this project; and

WHEREAS, the SPH Service Area Board unanimously passed a motion asking that the borough assembly appropriate the funds necessary to complete the project with a shortened hearing in order to avoid delays to the SPH expansion project.

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That \$450,000 is appropriated from unreserved retained earnings of the South Peninsula Hospital Enterprise Fund to account 601.81211.49999.99UST for removal of the existing underground storage tank, site remediation, installation of a new above ground tank, and associated structural and civil work at the South Peninsula Hospital.

SECTION 2. That this ordinance takes effect immediately upon enactment.
