KENAI PENINSULA BOROUGH ORDINANCE 99-53

AN ORDINANCE APPROPRIATING IN PART AND REAPPROPRIATING IN PART A STATE GRANT AND LOCAL MATCHING FUNDS TO THE SOUTH PENINSULA HOSPITAL SERVICE AREA HOSPITAL EXPANSION PROJECT

- WHEREAS, in 1995 the Kenai Peninsula Borough was awarded a grant of \$17,183 under the Municipal Capital Project Matching Grant Program (AS 37.06.010) for the South Peninsula Hospital ("SPH") oxygen system; and
- WHEREAS, the total project amount of \$24,547, including the above state grant and the local share of \$7,364, was insufficient to replace the oxygen system; and
- WHEREAS, grant funds of \$7,463 and local matching funds of \$3,198 were previously appropriated in Ordinance 97-30 for upgrading the SPH oxygen system; and
- **WHEREAS,** \$3,198 of the project funds have been expended toward the oxygen system, leaving a balance of \$21,349.00 which includes:

\$9,720.00 in unappropriated grant funds

\$4,166.00 in unappropriated local matching funds;

\$5,224.40 in previously appropriated grant funds; and

\$2,238.60 in previously appropriated local matching funds; and

- WHEREAS, the hospital's service area board and operating board have requested that the remaining funds be reappropriated to the hospital's expansion project; and
- WHEREAS, during this past session, the Alaska State Legislature authorized reappropriations to amend the purposes of the grant to read: South Peninsula Hospital Service Area Hospital Addition and Renovation;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That the Mayor is authorized to execute an amended grant agreement, thereby accepting the provisions therein, and to accept a grant for South Peninsula Hospital Service Area Hospital Addition and Renovation as reappropriated by the Alaska Legislature (Chapter 2, FSSLA 1999).

- **SECTION 2.** That grant funds in the amount of \$9,720.00 are hereby accepted and appropriated to account No. 601-81211-M5883-49999 (Capital Projects).
- **SECTION 3.** That grant funds of \$5,224.40 currently in account No. 601-81211-M5883-49999 (Capital Projects) shall be reappropriated for use in the SPH Service Area Hospital Addition and Renovation project; and
- **SECTION 4**. That local match requirements will be satisfied through local tax sources as follows:
 - (A) \$4,166.00 is reappropriated and transferred from account No. 601-81211-49999 (Contingency) to account No. account No. 601-81211-M5883-49999 (Capital Projects); and
 - (B) \$2,238.60 currently in account No. 601-81211-M5883-49999 (Capital Projects) shall be reappropriated and identified as funds for the SPH Service Area Hospital Addition and Renovation project.

SECTION 5. That this ordinance takes effect immediately upon its enactment.
