**KENAI PENINSULA BOROUGH  
ORDINANCE 2001-10  
(MAYOR) SUBSTITUTE**

**AN ORDINANCE AUTHORIZING THE MAYOR TO EXECUTE DOCUMENTS  
NECESSARY TO ACCEPT RESPONSIBILITY FOR THE TRANSFER OF A  
COMMUNITY BLOCK GRANT FROM THE CITY OF SELDOVIA IN THE  
AMOUNT OF \$200,000**

- WHEREAS,** the Boys and Girls Club and Head Start program provide vital family support services in the community of Seldovia; and
- WHEREAS,** the Boys and Girls Club and Head Start programs provide services compatible with education functions; and
- WHEREAS,** the Boys and Girls Club in Seldovia operates out of the ball closet in the Seldovia school gymnasium; and
- WHEREAS,** the Seldovia Head Start program's current facility is being demolished, and space will be needed by the beginning of the 2002-03 school year; and
- WHEREAS,** the Boys and Girls Club has an opportunity to receive grant funding to construct a building; and
- WHEREAS,** the KPB school board voted on February 19, 2001, to make land available for a portable building for the Boys and Girls Club and Head Start program adjacent to the Seldovia Susan B. English School building; and
- WHEREAS,** the City of Seldovia has been awarded a Community Development Block Grant to the Seldovia Community Center project which would house the Boys and Girls Club and Head Start program that must be expended by December 31, 2001; and
- WHEREAS,** after meetings with the City of Seldovia, the school district, borough officials, and Boys and Girls Club officials, it has been agreed that the simplest mechanism for enabling the Boys and Girls Club and Head Start programs to occupy this facility and to receive the grant funds from the state would be for the City of Seldovia to transfer the Community Development Block Grant to the Kenai Peninsula Borough to help fund construction of the facility for the school district and to transfer this facility to the school district; and

**WHEREAS,** the council of the City of Seldovia at its meeting of April 25, 2001 authorized the transfer of this grant to the Kenai Peninsula Borough; and

**WHEREAS,** the school district has indicated a willingness to lease the facility to the Boys and Girls Club and Head Start programs to accommodate this need; and

**WHEREAS,** a facility lease does not require that the property be subdivided;

**WHEREAS,** in order to transfer the grant to the Kenai Peninsula Borough the State of Alaska first requires a letter from the borough accepting responsibility for the grant agreement;

**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** The assembly authorizes the administration to execute such documents as are necessary to indicate the borough's willingness to accept responsibility for the above-described Community Development Block Grant in the amount of \$200,000 for the purposes described hereinabove relating to construction of a facility to be located on the following described property:

**SECTION 2.** This ordinance takes effect immediately upon enactment
