**KENAI PENINSULA BOROUGH
ORDINANCE 2001-19-19**

**AN ORDINANCE RE-APPROPRIATING \$132,381 FROM THE CENTRAL
PENINSULA MIDDLE SCHOOL CONCEPT PROJECT TO THE SEWARD MIDDLE
SCHOOL CODE REVIEW PROJECT (\$70,000) AND THE SOLDOTNA MIDDLE
SCHOOL RECONFIGURATION PROJECT (\$62,381)**

- WHEREAS,** eight portable buildings at Soldotna Middle School continue to be required to help house approximately 575 students; and
- WHEREAS,** in order to help alleviate the overcrowding, the School District Administration (SD) wishes to perform a preliminary design of renovations to existing space within the Soldotna Middle School that will create at least four (4) new classrooms; and
- WHEREAS,** the constant need to upgrade the Seward Middle School's plant systems has led the KPB School District School Board (SB) to require a review of the entire Seward Middle School building's code compliance; and
- WHEREAS,** annual inspections by the State of Alaska Fire Marshal and the local City Fire Marshal of Seward continue to show upgrades are needed of many items for code compliance, including such systems as the electrical, fire alarm, ADA building and bathroom access, and wall construction; and
- WHEREAS,** the KPB desires to comply with the applicable codes to assure full compliance for the public's health and safety; and
- WHEREAS,** the KPBSD forwarded a letter in April 2001, requesting that these two review issues be initiated; and
- WHEREAS,** the SB approved moving forward with the Soldotna Middle School Reconfiguration and the Seward Middle School Code Review Projects at its meeting of February 5, 2001; and
- WHEREAS,** the SD no longer sees a need to complete the Central Peninsula Middle School Concept Project and that \$132,381 in unencumbered funds are therefore available for re-appropriation; and

WHEREAS, hearing on shortened time is necessary to enable work to begin on these projects in time to identify and implement solutions during the 2002 construction season;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That the Central Peninsula Middle School Concept Project is cancelled and that \$132,381 in unencumbered funds are available for re-appropriation from project account number 401.71181.93045.49999 to other school capital improvement projects.


SECTION 2. That \$132,381 in unencumbered funds are transferred from fund 401 to fund 400.

SECTION 3. That \$70,000 is re-appropriated to the Seward Middle School Code Review Project account number 400.75030.02CDR.49999 and that \$62,381 is re-appropriated to the Soldotna Middle School Reconfiguration Project account number 400.76030.02RCF.49999.


SECTION 4. That the appropriations established through this ordinance are of a project length nature and as such do not lapse at the end of any particular fiscal year.

SECTION 5. That this ordinance shall become effective immediately upon enactment.
