**KENAI PENINSULA BOROUGH
ORDINANCE 2001-19-20**

**AN ORDINANCE ACCEPTING AND APPROPRIATING THE COASTAL IMPACT
ASSISTANCE PROGRAM GRANT FUNDS IN THE AMOUNT OF \$208,665**

WHEREAS, a Coastal Impact Assistance Program (CIAP) was established by Congress and passed into law in 2001; and

WHEREAS, the purpose of the CIAP is to provide a one-time distribution of \$150 million to oil producing states to mitigate the effects of offshore oil and gas development; and

WHEREAS, eligible recipients of CIAP funds in Alaska are those communities that participate in the Alaska Coastal Management Program, which includes the Kenai Peninsula Borough; and

WHEREAS, the Assembly finds it is in the best interest of the Kenai Peninsula Borough to participate in the Coastal Impact Assistance Program; and

WHEREAS, the Kenai Peninsula Borough has been awarded \$208,665 under the CIAP, and no local match is required; and

WHEREAS, eleven worthy projects throughout the Peninsula have been identified and approved through adoption of KPB Resolution 2001-041, and have also been approved by the National Oceanic and Atmospheric Administration;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That the mayor is authorized to execute grant agreements and any other documents necessary to accept the above-described grants from the National Oceanic and Atmospheric Administration through its Coastal Impact Assistance Program.


SECTION 2. That grant funds totaling \$208,665 are hereby appropriated to the following account numbers for the purpose of completing the projects approved in KPB Resolution 2001-041:


SECTION 3. That the appropriations established through this ordinance are of a project length nature and as such do not lapse at the end of any particular fiscal year.
