KENAI PENINSULA BOROUGH ORDINANCE 2001-19-30

AN ORDINANCE APPROPRIATING \$1,400,000 IN SUPPLEMENTAL FUNDING FOR SCHOOL RELATED CAPITAL MAINTENANCE AND IMPROVEMENT PROJECTS

- WHEREAS, the Kenai Peninsula Borough has recently completed the 2002 annual update to the Capital Improvement Projects list; and
- WHEREAS, the Kenai Peninsula Borough School District requested that the borough provide an additional one million dollars in supplemental funding for school capital maintenance and improvement projects; and
- WHEREAS, in reviewing the Capital Improvement Project list, some additional out-year projects were identified that require planning and design work for future construction; and
- WHEREAS, early funding some of the proposed projects would allow early bidding thereby allowing construction work to be scheduled during the summer months avoiding the need for temporary school closures during the school year.

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That general fund balance of \$800,000 is hereby transferred to the school revenue capital projects fund and appropriated to the following school capital maintenance and improvement projects requested by the school district:
