AN ORDINANCE APPROPRIATING FUNDS FOR FISCAL YEAR 2001-2002

- WHEREAS, Alaska Statutes 29.35.100 and the Borough Code of Ordinances 05.04.020 require that the Mayor present a budget proposal to the Assembly for the next fiscal year during or prior to the eighth week preceding the first day of the fiscal year; and
- WHEREAS, the Assembly is empowered with making appropriations for the General Fund, the Special Revenue Funds, the Debt Service Funds, the Capital Projects Funds, the Enterprise Funds, and the Internal Service Funds of the Borough; and
- WHEREAS, Resolution 2001-044 approved a total school budget of \$88,420,316 and established that up to \$30,954,648 (\$24,386,032 local effort and \$6,086,948 inkind services and funding outside the cap for school technology of \$481,668) be provided from local sources for school purposes; and
- WHEREAS, the Assembly is required by KPB 5.04.021 to appropriate the money for school purposes before June 15.

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That \$50,824,079 is appropriated in the General Fund for the fiscal year beginning July 1, 2001 and ending June 30, 2002 as follows:

Any available balance remaining at the end of the fiscal year shall then be disbursed to the school district, provided that the total amount disbursed shall not exceed the amount allowed under AS 14.17.410 as determined after actual enrollment numbers are known.


