**KENAI PENINSULA BOROUGH  
ORDINANCE 2002-19-06**

**AN ORDINANCE ACCEPTING AND APPROPRIATING A GRANT IN THE AMOUNT  
OF \$45,000 FROM THE ALASKA DEPARTMENT OF COMMUNITY AND  
ECONOMIC DEVELOPMENT FOR ARCTIC WINTER GAMES**

- WHEREAS,** the Kenai Peninsula Borough wishes to submit a bid package to bring the 2006 Arctic Winter Games to the Kenai; and
- WHEREAS,** an Arctic Winter Games 2006 Bid Committee has been formed to prepare the bid documents and participate in the bidding process; and
- WHEREAS,** funding is needed to coordinate the efforts of the Bid Committee to complete the bid documents and prepare for the on-site visit from the Arctic Winter Games International Committee; and
- WHEREAS,** notice has been received from the Alaska Department of Community and Economic Development that a legislative grant was awarded to the Borough in the amount of \$45,000 for the Arctic Winter Games; and
- WHEREAS,** the Arctic Winter Games could bring 1,600 athletes, coaches and officials to the Kenai Peninsula, generating several million dollars in revenue to local businesses; and
- WHEREAS,** hosting the Arctic Winter Games on the Peninsula provides an opportunity to showcase our rich cultural heritage to participants and visitors from Canada, Russia, Greenland and other parts of Alaska; and
- WHEREAS,** since the bid documents are due by October 1, 2002, a shortened hearing is requested to provide funding to the Bid Committee as soon as possible in order to complete their initial task in a timely manner;


**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** That the mayor is authorized to accept the above-described grant from the Department of Community and Economic Development and is authorized to execute all documents deemed necessary to accept the grant.


**SECTION 2.** That grant funds in the amount of \$45,000 are appropriated to account 272.11225.03063.43011.
