**KENAI PENINSULA BOROUGH  
ORDINANCE 2002-19-11**

**AN ORDINANCE AUTHORIZING THE RECEIPT OF A MUNICIPAL CAPITAL  
MATCHING GRANT FROM THE STATE OF ALASKA FOR ROAD PROJECTS; AND  
APPROPRIATING \$497,495 TO A CAPITAL PROJECT ACCOUNT**

- WHEREAS,** the Borough has received notification from the State Department of Community and Economic Development of grant award for fiscal year 2002/03 through the municipal capital matching grant program for the purpose of borough-wide road improvement projects, and that \$497,495 has been awarded to the Borough for this purpose; and
- WHEREAS,** for each capital project grant that a municipality receives, a local match, or local share of the cost, must be provided by the municipality; and
- WHEREAS,** Alaska Statute 37.06.030 requires that municipalities with a population greater than 5,000 provide a 30% local match; and
- WHEREAS,** under AS 37.06.030, the Borough's local share percentage is 30%, or \$213,213 for the FY'03 grant; and
- WHEREAS,** matching funds in the amount of \$213,213 were previously appropriated in the Road Service Area's Capital Project Fund budget for fiscal year 2002/2003; and
- WHEREAS,** the local share contribution of \$213,213 and the State's allocation of \$497,495 will provide a total of \$710,708 to be used for road improvements on Borough-maintained roads; and
- WHEREAS,** through adoption of Resolution 2001-101 the Borough Assembly approved the list of road projects for inclusion in the State's FY'03 capital matching grant program; and
- WHEREAS,** at its regular meeting on August 13, 2002, the Service Area Board of Directors recommended acceptance of the grant for \$497,495 and approved expenditure of the required match in the amount of \$213,213.

**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**


**SECTION 1.** That the Mayor is authorized to execute a grant agreement, thereby accepting the provisions therein, and to accept a grant for capital improvement projects in the total amount of \$497,495 as appropriated by the Alaska Legislature.

**SECTION 2.** That grant funds in the amount of \$497,495 are hereby appropriated to the Road Service Area capital projects account No. 434.33950.M5803.43011.


**SECTION 3.** That due to the length and nature of this project, the appropriations established through this ordinance shall not lapse at the end of any particular fiscal year.

**SECTION 4.** That this ordinance takes effect immediately upon its enactment.
