**KENAI PENINSULA BOROUGH
ORDINANCE 2002-19-15**

**AN ORDINANCE ACCEPTING AND APPROPRIATING A GRANT OF \$74,310
FROM THE STATE OF ALASKA FOR THE KENAI PENINSULA BOROUGH
COASTAL MANAGEMENT PROGRAM**

- WHEREAS,** the Kenai Peninsula Borough Coastal Management Program provides coordinated planning and permitting within the coastal district boundary of the borough; and
- WHEREAS,** the Alaska Department of Community and Economic Development has approved the borough's request for Section 306 funding under the Alaska Coastal Management Program; and
- WHEREAS,** the Kenai Peninsula Borough has been awarded \$74,310 for use in administration and implementation of the Coastal Management Program; and
- WHEREAS,** the coastal management grant requires a local matching of \$22,293; and
- WHEREAS,** sufficient funds are included in the approved FY2003 budget to meet the grant's local match requirement of \$22,293; and
- WHEREAS,** at its meeting of August 26, 2002, the planning commission recommended enactment of the ordinance;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. The Kenai Peninsula Borough Assembly accepts a grant of \$74,310 from the State of Alaska to fund the Kenai Peninsula Borough Coastal Management Program.

SECTION 2. That the sum of \$74,310 is hereby appropriated into the following accounts in these respective amounts pursuant to the grant agreement:



SECTION 3. These funds shall be utilized to carry out the required tasks of the grant.


SECTION 4. The mayor is authorized to sign any documents necessary to effectuate the intents and purposes of this ordinance.
