## KENAI PENINSULA BOROUGH ORDINANCE 2002-19-22

## AN ORDINANCE AUTHORIZING RECEIPT OF A GRANT FROM THE ALASKA DEPARTMENT OF COMMUNITY AND ECONOMIC DEVELOPMENT FOR CONSTRUCTION OF A COMMUNITY EDUCATION CENTER IN SELDOVIA AND APPROPRIATING THE GRANT AWARD AMOUNT PLUS MATCHING CONTRIBUTIONS

- WHEREAS, through enactment of KPB Ordinance 2001-10 (Sub.), the Mayor was authorized to accept responsibility for a state community development block grant to be transferred from the City of Seldovia to the borough in the amount of \$200,000; and
- WHEREAS, through adoption of KPB Resolution 2001-091, the Mayor was authorized to participate in the state's Community Development Block Grant Program in cooperation with the Boys and Girls Club of the Kenai Peninsula, Inc. ("Boys and Girls Club"); and
- WHEREAS, the Alaska Department of Community and Economic Development and the Borough have entered into negotiations for a grant agreement; and
- WHEREAS, the Kenai Peninsula Borough will have sole responsibility for complying with the terms and conditions of the grant agreement and, therefore, will provide project management through its Capital Projects Division; and
- WHEREAS, since the facility will be constructed on borough school property, managed by the Kenai Peninsula Borough School District, and leased to the Boys and Girls Club, the three parties have entered into a cooperative agreement for the purpose of setting out each party's responsibilities; and
- WHEREAS, the borough has authority to acquire, manage, and use real property, and to maintain a system of public schools as provided in AS 14.14.060; and
- WHEREAS, the Boys and Girls Club has agreed to provide all matching cash or in-kind contributions necessary for grant award and compliance, and will reserve these matching funds until the project is completed; and
- **WHEREAS,** upon completion of the project, the Boys and Girls Club will have sole responsibility for operation and maintenance of the educational center; and

WHEREAS, a shortened hearing date is requested for this ordinance in order to have the project ready for construction prior to the 2003 construction season;

## NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI **PENINSULA BOROUGH:**

- **SECTION 1.** That the mayor is authorized to execute a grant agreement and related documents in order to accept community development block grant funds in an amount up to \$200,000 for construction of a community education center in Seldovia.
- SECTION 2. That any matching requirements will be satisfied through cash or in-kind contribution from the Boys and Girls Club of the Kenai Peninsula, a nonprofit corporation organized under the laws of Alaska and recognized by the Internal Revenue Service as a tax exempt organization. The cash match shall not be less than \$230,000.
- SECTION 3. That funds in the amount of \$430,000 are appropriated to account 271.32141.03B&G.49999 for the construction of a community education center in Seldovia.
- SECTION 4. That due to the length and nature of this project, the appropriation established through this ordinance shall not lapse at the end of any particular fiscal year.
- SECTION 5. This ordinance shall become effective immediately upon enactment.
