**KENAI PENINSULA BOROUGH
ORDINANCE 2002-19-25**

**AN ORDINANCE ACCEPTING AND APPROPRIATING STATE FUNDS FROM THE
ALASKA DEPARTMENT OF COMMUNITY AND ECONOMIC DEVELOPMENT IN
THE AMOUNT OF \$73,550 FOR THE COOK INLET SALMON BRANDING
PROGRAM**

- WHEREAS**, the Cook Inlet Salmon Brand, Inc. ("CISB"), requested funding from the State legislature for providing support to its salmon branding program; and
- WHEREAS**, Senate Bill 2006, which included funding for the CISB's project, was passed by the State Legislature and signed by the Governor; and
- WHEREAS**, notice has been received from the Alaska Department of Community and Economic Development that a legislative grant has been awarded to CISB in the amount of \$93,000 for its quality control program; and
- WHEREAS**, through enactment of KPB Ordinance 2001-19-32 the Borough Assembly appropriated \$305,550 to the Cook Inlet Sockeye Branding Project; and
- WHEREAS**, KPB Ordinance 2001-19-32 states that receipt of other funds for this project would be used to offset the Borough's amount contributed; and
- WHEREAS**, a State grant in the amount of \$120,000 to the Kenai Peninsula Borough was appropriated to the program through enactment KPB Ordinance 2001-19-37; and
- WHEREAS**, a grant in the amount of \$112,000 from the Alaska Manufacturer's Association to the Kenai Peninsula Borough was appropriated to the program through enactment of KPB Ordinance 2002-19-10; and
- WHEREAS**, CISB wishes to fulfill its obligation to the Borough by transferring \$73,550 from its legislative grant to the Borough, thereby replacing the entire \$305,550 originally appropriated;

**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI
PENINSULA BOROUGH:**

SECTION 1. That the mayor is authorized to accept the grant funds from the Department of Community and Economic Development on behalf of Cook Inlet Salmon Brand, Inc., and is authorized to execute all documents deemed necessary to accept the grant.

SECTION 2. That funds in the amount of \$73,550 are appropriated to account 275.11225.BRAND.49999.


SECTION 3. That the previous appropriation in Ordinance 2001-19-32 is hereby reduced by \$73,550.

SECTION 4. That CISB has satisfied its obligation to the Borough by replacing the entire \$305,550 originally appropriated for the Cook Inlet Salmon Branding Project in Ordinance 2001-19-32.

SECTION 5. That due to the length and nature of this project, the appropriations established through this ordinance shall not lapse at the end of any particular fiscal year.


SECTION 6. This ordinance shall become effective immediately upon enactment.
