KENAI PENINSULA BOROUGH ORDINANCE 2002-19-41

AN ORDINANCE ACCEPTING A GRANT FROM THE ALASKA DEPARTMENT OF NATURAL RESOURCES IN THE AMOUNT OF \$30,000 FOR JACOB'S LADDER TRAIL IMPROVEMENTS AND APPROPRIATING THE GRANT AND MATCHING FUNDS (\$20,000) TO A PROJECT ACCOUNT

- **WHEREAS,** Jacobs Ladder Drive/Trail, used primarily by ATVs and other recreational users, is located in the northern peninsula and is currently unusable due to erosion; and
- WHEREAS, the Alaska Department of Natural Resources offers grant funding through its Recreational Trails Program; and
- WHEREAS, the Borough Planning Department applied for funding under the Recreational Trails Program to improve Jacobs Ladder Drive trail, thereby providing access to lands within the northern peninsula for landowners and recreational users; and
- WHEREAS, the grant application was supported by the Borough Assembly through Resolution 2002-113, the Road Service Area Board through their Resolution 02-04, and by numerous agencies and citizens in the northern peninsula; and
- WHEREAS, the cost of the project is expected to be approximately \$49,630.00; and
- WHEREAS, the Borough has received notice of award of a grant in the amount of \$30,000; and
- WHEREAS, the grant requires a minimum match of twenty percent of the project cost; and
- **WHEREAS**, \$20,000 is currently available for this project in the Land Trust Fund balance, which exceeds the matching requirement and will provide sufficient funding to complete the trail improvements;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That the mayor is authorized to accept a grant from the Alaska Department of Natural Resources in the amount of \$30,000 for trail improvements to Jacobs Ladder Drive and is authorized to execute a grant agreement and any other documents deemed necessary to accept the grant.

- **SECTION 2.** That grant funds in the amount of \$30,000 are appropriated to account number 409.21210.3JAKE.43011, miscellaneous grants contract services.
- **SECTION 3.** That matching funds in the amount of \$20,000 are appropriated from the Land Trust Fund balance to account 250.21210.00000.50409, interfund transfers.
- **SECTION 4.** That \$20,000 in interfund transfers from the Land Trust Fund shall be appropriated to account 409.21210.3JAKE.43011.
- **SECTION 5.** That due to the length and nature of this project, the appropriations established through this ordinance shall not lapse at the end of any particular fiscal year.
- **SECTION 6.** This ordinance shall become effective immediately upon its enactment.
