### AN ORDINANCE AMENDING THE ASSEMBLY AGENDA'S ORDER OF BUSINESS TO PROVIDE FOR COMMITTEE REPORTS PRIOR TO ASSEMBLY CONSIDERATION OF ITEMS ON THE CONSENT AGENDA

- WHEREAS, the assembly agenda currently provides for approval of the agenda and consent agenda prior to reports of assembly committees; and
- WHEREAS, each item appearing on the assembly's agenda is reviewed by one or more committees prior to the meeting; and
- WHEREAS, occasionally, questions regarding specific consent agenda items are raised and answered at the committee level; and
- **WHEREAS,** it is in the best interest of both the public and the assembly that the committee report and recommendations regarding consent agenda items be presented prior to public comment and assembly action on the consent agenda;

## NOW, THEREFORE, BE IT ORDAINED BY THE KENAI PENINSULA BOROUGH ASSEMBLY:

**SECTION 1.** That KPB 22.40.080, Agenda - Order of Business, is hereby amended to read as follows:

- M. Public hearings on ordinances (Testimony limited to 3 minutes per speaker);
- N. Unfinished business;
  - 1. Postponed items
  - 2. Notices to reconsider/rescind;
- O. New business;
  - 1. Bid awards
  - 2. Resolutions
  - 3. Ordinances for introduction
  - 4. Other (including addition of late items);
- P. Public comments and public presentations (Limited to 3 minutes per speaker);
- Q. Assembly meeting and hearing announcements;
- R. Assembly comments;
- S. Pending legislation;
- T. Informational materials and reports;
- U. Notice of next meeting and adjournment;

**SECTION 2.** That this ordinance shall take effect immediately upon enactment.
