## KENAI PENINSULA BOROUGH ORDINANCE 2003-19-07

## AN ORDINANCE ACCEPTING AND APPROPRIATING \$100,000 FROM THE BOYS AND GIRLS CLUB OF THE KENAI PENINSULA FOR THE COMMUNITY EDUCATION CENTER IN SELDOVIA

- WHEREAS, the Alaska Department of Community and Economic Development ("DCED"), the Boys and Girls Club of the Kenai Peninsula, Inc. ("Boys and Girls Club"), the Kenai Peninsula Borough School District ("School District"), and the Kenai Peninsula Borough ("Borough") have entered into agreements to construct a facility to provide organized youth activities in Seldovia; and
- WHEREAS, funding in the amount of \$430,000 was made available for this project through grants from the State and private foundations, as well as from private individuals and the Seldovia Village Tribe; and
- WHEREAS, the Borough recently published a request for proposals to construct the facility in Seldovia; and
- **WHEREAS,** the results of the bid opening indicate that additional funding in the amount of \$100,000 is needed to complete a 2,400 square foot building as designed; and
- WHEREAS, the Cooperative Agreement between the Boys and Girls Club, the School District, and the Borough states that "Neither the Borough nor the School District shall be liable for any funding. .... In the event that insufficient funding is provided to complete the project, or there are cost overruns, the Boys and Girls Club shall be solely responsible for financing any remaining construction ..."; and
- **WHEREAS,** the Boys and Girls Club has committed to provide an additional \$100,000 towards the project; and
- **WHEREAS,** since the DCED and Rasmuson Foundation grants expire on December 31, 2003, a shortened hearing date is requested in order to award the construction bid as soon as possible;

## NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

**SECTION 1.** That the mayor is authorized to accept funding from the Boys and Girls Club in the amount of \$100,000 for the community educational center in Seldovia and is authorized to execute any documents deemed necessary to accept the funds.

**SECTION 2.** That funds in the amount of \$100,000 are appropriated to account 271.32141.03B&G.49999.

**SECTION 3.** This ordinance shall become effective immediately upon enactment.
