**KENAI PENINSULA BOROUGH  
ORDINANCE 2003-19-14**

**AN ORDINANCE ACCEPTING TWO GRANTS FROM THE STATE OF ALASKA FOR  
THE KENAI PENINSULA BOROUGH COASTAL MANAGEMENT PROGRAM AND  
APPROPRIATING GRANT FUNDS IN THE AMOUNT OF \$36,071**

**WHEREAS,** the Kenai Peninsula Borough Coastal Management Program provides coordinated planning and permitting within the coastal boundaries of the borough; and

**WHEREAS,** the Alaska Department of Community and Regional Affairs has awarded the borough supplemental funding for meeting the high volume of reviews under the Coastal Management Program and for initiating the Coastal Zone Management Plan update; and

**WHEREAS,** the borough has received notice of award of two grants; one in the amount of \$32,857.00 to provide staffing assistance, and one in the amount of \$3,214 for scoping policy changes, for a total of \$36,071 for the Borough's Coastal Management Program; and

**WHEREAS,** the grant program requires a local match for each grant in the amount of 40%, or a total match of \$14,429 (\$13,143 plus \$1,286); and

**WHEREAS,** sufficient funds are included in the approved FY2004 budget to meet the grant's local match requirement of \$14,429;

**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** That the mayor is authorized to accept two grants from the Alaska Department of Community and Economic Development, one in the amount of \$32,857 and one in the amount of \$3,214 for the Coastal Management Program and is authorized to execute any grant agreements and any other documents deemed necessary to accept the grants.

**SECTION 2.** That grant funds in the amount of \$32,857 are hereby appropriated to:



**SECTION 3.** That grant funds in the amount of \$3,214 are hereby appropriated to account 257.22140.21480.43011, contract services.


**SECTION 4.** That due to the length and nature of this project, the appropriations established through this ordinance shall not lapse at the end of any particular fiscal year.
