**KENAI PENINSULA BOROUGH
ORDINANCE 2003-19-18**

**AN ORDINANCE ACCEPTING AND APPROPRIATING A GRANT FROM THE
ALASKA DEPARTMENT OF COMMUNITY AND ECONOMIC DEVELOPMENT IN
THE AMOUNT OF \$120,000 FOR AN AMBULANCE FOR THE NIKISKI FIRE
SERVICE AREA**

- WHEREAS,** the Nikiski Fire Service Area (“Service Area Board”) identified as a high priority the need to replace its present ambulance because of age and mileage, and included a request for \$150,000 for an ambulance in the Borough’s 2003 legislative priorities; and
- WHEREAS,** the Service Area had funds available in its FY03 capital projects account to purchase an ambulance; and
- WHEREAS,** at its meeting of April 9, 2003, the Service Area Board recommended award of a contract to United Fire Service, Inc., for the purchase of a Type I certified ambulance; and
- WHEREAS,** through adoption of Borough Resolution 2003-059 on May 20, 2003, the Assembly approved the award of the contract to United Fire Service, Inc., in the amount of \$143,286; and
- WHEREAS,** Senate Bill 100, which included funding for the Service Area’s project, was passed by the State Legislature and signed by the Governor; and
- WHEREAS,** on July 18, 2003, notice was received from the Alaska Department of Community and Economic Development that a legislative grant was awarded to the Service Area in the amount of \$120,000 for an ambulance; and
- WHEREAS,** at its regular meeting on September 10, 2003, the Service Area Board of Directors recommended acceptance; and
- WHEREAS,** acceptance and appropriation of the legislative grant will partially reimburse the Service Area for costs encumbered for the purchase of the ambulance, which is scheduled for delivery in early 2004;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:


SECTION 1. That the mayor is authorized to accept a legislative grant from the Alaska Department of Community and Economic Development on behalf of the Nikiski Fire Service Area in the amount of \$120,000 for purchase of an ambulance and is authorized to execute all documents deemed necessary to accept the grant.

SECTION 2. That grant funds in the amount of \$120,000 are appropriated to account 441.51111.03AMB.48514.


SECTION 3. That due to the length and nature of this project, the appropriations established through this ordinance shall not lapse at the end of any particular fiscal year.

SECTION 4. This ordinance shall become effective immediately upon enactment.
