AN ORDINANCE ACCEPTING AND APPROPRIATING A GRANT FROM THE DENALI COMMISSION IN THE AMOUNT OF \$250,000 FOR A BULK OXYGEN GENERATING SYSTEM AT SOUTH PENINSULA HOSPITAL

- WHEREAS, in order to meet the current and future medical oxygen needs of its patients, South Peninsula Hospital would like to purchase and install a bulk oxygen generating system; and
- WHEREAS, a new oxygen generating system will provide reliable and safe delivery of oxygen to patients and meet the projected growth rate needs for the next ten to twenty years; and
- WHEREAS, the Denali Commission has established a program, which is administered by the Alaska Department of Health and Social Services, to provide funding for health and social service projects in Alaska communities; and
- **WHEREAS,** the South Peninsula Hospital submitted an application to the Denali Commission to request funding for an oxygen generating system that could be installed concurrently with the hospital expansion project; and
- WHEREAS, South Peninsula Hospital has received notice of award of a grant in the amount of \$250,000 for purchase and installation of a bulk oxygen system; and
- WHEREAS, the grant program requires a cost share match in the amount of 50 percent of the project, or in this case, an additional \$250,000; and
- WHEREAS, funds to meet the match requirement are included in the funding for the South Peninsula Hospital expansion project, and will be available upon enactment of KPB Ordinance 2003-19-17; and
- WHEREAS, at its regularly scheduled meeting held October 2, 2003, the South Kenai Peninsula Hospital Service Area Board recommended adoption; and
- WHEREAS, at its regularly scheduled meeting held October 22, 2003, the South Peninsula Hospital, Inc. Board recommended adoption; and

WHEREAS, the local share contribution of \$250,000 and the Denali Commission grant amount of \$250,000 will provide a total of \$500,000 to be used for purchase and installation of a new bulk oxygen system at South Peninsula Hospital;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- **SECTION 1.** That the mayor is authorized to accept a grant from the Denali Commission, through the Alaska Department of Health and Social Services, in the amount of \$250,000 for a bulk oxygen system at South Peninsula Hospital and is authorized to execute a grant agreement and any other documents deemed necessary to accept the grant.
- SECTION 2. That grant funds in the amount of \$250,000 are hereby appropriated to account 491.81211.04SHB.49101.
- **SECTION 3.** That matching funds in the amount of \$250,000 are available and authorized for this project in the South Peninsula Hospital expansion construction account (491.81211.04SHB.49101).
- **SECTION 4.** That due to the length and nature of this project, the appropriations established through this ordinance shall not lapse at the end of any particular fiscal year.
- **SECTION 5.** This ordinance shall become effective immediately upon enactment.
