KENAI PENINSULA BOROUGH ORDINANCE 2003-19

AN ORDINANCE APPROPRIATING FUNDS FOR FISCAL YEAR 2003-2004

- WHEREAS, Alaska Statutes 29.35.100 and the Borough Code of Ordinances 05.04.020 require that the Mayor present a budget proposal to the Assembly for the next fiscal year during or prior to the eighth week preceding the first day of the fiscal year; and
- **WHEREAS,** the Assembly is empowered with making appropriations for the General Fund, the Special Revenue Funds, the Debt Service Funds, the Capital Projects Funds, the Enterprise Funds, and the Internal Service Funds of the Borough; and
- WHEREAS, Resolution 2003-049 approved a total school budget of \$89,270,459 and established that up to \$31,100,465 (\$24,695,341 local effort and \$6,405,124 in-kind services) be provided from local sources for school purposes; and
- WHEREAS, the Assembly is required by KPB 5.04.021 to introduce an ordinance at the May 6, 2003 meeting appropriating the amount to be made available from local sources for school purposes, and by AS 14.14.060 to enact such ordinance by June 30.

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That \$55,725,452 is appropriated in the General Fund for the fiscal year beginning July 1, 2003 and ending June 30, 2004 as follows:

- **SECTION 3.** Disbursements from Section 2 item (A) shall be made monthly, and only as needed to supplement other revenues available and received by the school district to fund the operations portion of the school district budget. Any available balance remaining at the end of the fiscal year shall then be disbursed to the school district, provided that the total amount disbursed shall not exceed the amount allowed under AS 14.17.410 as determined after actual enrollment numbers are known.
