**KENAI PENINSULA BOROUGH
ORDINANCE 2003-40**

**AN ORDINANCE INCORPORATING THE 2003 KENAI PENINSULA BOROUGH
TRANSPORTATION PLAN AS AN ELEMENT OF THE KENAI PENINSULA
BOROUGH COMPREHENSIVE PLAN**

WHEREAS, the Kenai Peninsula Borough was the recipient of a grant from the Alaska Department of Transportation to provide an intermodal transportation plan for the borough for use in comprehensive planning; and

WHEREAS, the borough contracted with HDR Alaska for services outlined in its proposal to establish a 2003 Kenai Peninsula Borough Transportation Plan; and

WHEREAS, a public participation process was undertaken that included twenty public meetings held in ten communities within the borough, two stakeholder meetings, an interactive website, and appearances on radio call-in shows; and

WHEREAS, the draft plan was reviewed by the public, the stakeholders, three advisory planning commissions, and the Kenai Peninsula Borough Planning Commission; and

WHEREAS, Ordinance 92-10 provides that as additional elements are developed, reviewed, and approved by the Assembly these elements shall be incorporated into the Comprehensive Plan, and that the Comprehensive Plan shall be reviewed periodically and updated as socio-economic conditions of the borough change; and


WHEREAS, the Planning Commission at its November 24, 2003 meeting recommended enactment by unanimous vote;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:


SECTION 1. That the 1992 Kenai Peninsula Borough Comprehensive Plan is hereby amended by deleting chapter 4 entitled "Transportation" and substituting it with the document entitled "2003 Kenai Peninsula Borough Transportation Plan," a copy of which shall be on file in both the Borough Clerk's office and the Borough Planning Department.


SECTION 2. That this ordinance shall take effect immediately upon its enactment.
