**KENAI PENINSULA BOROUGH
ORDINANCE 2004-19-03**

**AN ORDINANCE ACCEPTING AND APPROPRIATING FOUR VOLUNTEER FIRE
ASSISTANCE GRANTS FROM THE ALASKA DEPARTMENT OF NATURAL
RESOURCES**

WHEREAS, several of the fire service areas applied for a grant under the 2004 Volunteer Fire Assistance program administered by the Alaska Department of Natural Resources, Division of Forestry; and

WHEREAS, notice has been received that four grants have been awarded as follows: (1) Anchor Point Fire and Emergency Medical Service Area ("APFSA") - \$1,981.00, (2) Bear Creek Fire Service Area ("BCFSA") - \$4,997.50, (3) Kachemak Emergency Service Area ("KESA") - \$4,925.00, and (4) Nikiski Fire Service Area - \$2,622.00 ("NFSA"); and

WHEREAS, the Volunteer Fire Assistance Grant program requires a one-to-one match of local expenditures to the grant funds, such expenditures to be made during the 2004 calendar year; and

WHEREAS, the four service areas will meet the match requirement through expenditures made from their operating budgets prior to December 31, 2004, for fire fighting equipment and/or training;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That the mayor is authorized to accept the Volunteer Fire Assistance grant funds from the Department of Natural Resources on behalf of APFSA, BCFSA, KESA, and NFSA, and is authorized to execute a grant agreement and any other documents deemed necessary to accept and expend the grant and to fulfill the intents and purposes of this ordinance.

SECTION 2. That grant funds are appropriated as follows:

\$1,981.00 to Account 209.51410.53VFA.48760, minor firefighting equipment, APFSA


\$4,997.50 to Account 207.51210.52VFA.48514, firefighting and rescue equipment, BCFSA

\$4,925.00 to Account 212.51810.54VFA.48760, minor firefighting equipment, KESA


\$2,622.00 to Account 206.51110.51VFA.48760, minor firefighting equipment, NFSA

SECTION 3. This ordinance shall become effective immediately upon its enactment.
