**KENAI PENINSULA BOROUGH  
ORDINANCE 2007-19-03**

**AN ORDINANCE ACCEPTING AND APPROPRIATING ON BEHALF OF ANCHOR  
POINT FIRE AND EMERGENCY MEDICAL SERVICE AREA A VOLUNTEER FIRE  
ASSISTANCE GRANT FROM THE ALASKA DEPARTMENT OF NATURAL  
RESOURCES**

**WHEREAS,** the Anchor Point Fire and Emergency Medical Service Area (“Service Area”) applied for a grant under the 2007 Volunteer Fire Assistance (“VFA”) grant program administered by the Alaska Department of Natural Resources, Division of Forestry; and

**WHEREAS,** notice was received that a VFA grant in the amount of \$5,931 has been awarded to the Service Area; and

**WHEREAS,** the VFA grant program requires a minimum 10 percent match of local expenditures to the grant funds, such expenditures to be made during the 2007 calendar year; and

**WHEREAS,** the Service Area will meet the match requirement through expenditures made from its operating budget prior to December 31, 2007, for fire fighting equipment and/or training; and

**WHEREAS,** at a regular board meeting held on July 16, 2007, the Service Area Board of Directors recommended that this grant be accepted; and

**WHEREAS,** as the grant funds and matching funds must be expended prior to December 31, 2007, a shortened public hearing date is requested; and

**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**


**SECTION 1.** That the mayor is authorized to accept a Volunteer Fire Assistance Grant from the Department of Natural Resources on behalf of Anchor Point Fire and Emergency Medical Service Area and is authorized to execute a grant agreement and any other documents deemed necessary to accept and expend the grants and to fulfill the intents and purposes of this ordinance.

**SECTION 2.** That grant funds are appropriated to the Service Area accounts as follows:

\$5,756 to Account 209.51410.8VFA2.49999 – Project Account  
\$ 175 to Account 209.51410.8VFA2.61990 – Administrative Service Fee

**SECTION 3.** This ordinance shall become effective immediately upon its enactment.
