## KENAI PENINSULA BOROUGH **ORDINANCE 2007-19-04**

## AN ORDINANCE ACCEPTING AND APPROPRIATING ON BEHALF OF BEAR CREEK FIRE SERVICE AREA A VOLUNTEER FIRE ASSISTANCE GRANT FROM THE ALASKA DEPARTMENT OF NATURAL RESOURCES

- WHEREAS, Bear Creek Fire Service Area ("Service Area") applied for a grant under the 2007 Volunteer Fire Assistance ("VFA") grant program administered by the Alaska Department of Natural Resources, Division of Forestry; and
- WHEREAS, notice was received that a VFA grant in the amount of \$4,000 has been awarded to the Service Area; and
- WHEREAS, the VFA grant program requires a minimum 10 percent match of local expenditures to the grant funds, such expenditures to be made during the 2007 calendar year; and
- WHEREAS, the Service Area will meet the match requirement through expenditures made from its operating budget prior to December 31, 2007, for fire fighting equipment and/or training; and
- WHEREAS, at a regular board meeting held on July 10, 2007, the Service Area Board of Directors recommended that this grant be accepted; and
- WHEREAS, as the grant funds and matching funds must be expended prior to December 31, 2007, a shortened public hearing date is requested; and

## NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI **PENINSULA BOROUGH:**

- **SECTION 1.** That the mayor is authorized to accept a Volunteer Fire Assistance Grant from the Department of Natural Resources on behalf of Bear Creek Fire Service Area and is authorized to execute a grant agreement and any other documents deemed necessary to accept and expend the grants and to fulfill the intents and purposes of this ordinance.
- **SECTION 2.** That grant funds are appropriated to the Service Area accounts as follows:

\$3,882 to Account 207.51210.8VFA1.49999 – Project Account \$ 118 to Account 207.51210.8VFA1.61990 – Administrative Service Fee SECTION 3. This ordinance shall become effective immediately upon its enactment.
