KENAI PENINSULA BOROUGH **ORDINANCE 2007-19-07**

AN ORDINANCE ACCEPTING AND APPROPRIATING ON BEHALF OF KACHEMAK EMERGENCY SERVICE AREA A VOLUNTEER FIRE ASSISTANCE GRANT FROM THE ALASKA DEPARTMENT OF NATURAL RESOURCES

- WHEREAS, Kachemak Emergency Service Area ("Service Area") applied for a grant under the 2007 Volunteer Fire Assistance ("VFA") grant program administered by the Alaska Department of Natural Resources, Division of Forestry; and
- WHEREAS, notice was received that a VFA grant in the amount of \$6,746.00 has been awarded to the Service Area; and
- WHEREAS, the VFA grant program requires a minimum 10 percent match of local expenditures to the grant funds, such expenditures to be made during the 2007 calendar year; and
- WHEREAS, the Service Area will meet the match requirement through expenditures made from its operating budget prior to December 31, 2007, for fire fighting equipment and/or training; and
- WHEREAS, at its regular board meeting held on June 29, 2007, the Service Area Board of Directors recommended that this grant be accepted; and
- WHEREAS, as the grant funds and matching funds must be expended prior to December 31, 2007, a shortened public hearing date is requested; and

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- **SECTION 1.** That the mayor is authorized to accept a Volunteer Fire Assistance Grant from the Department of Natural Resources on behalf of Kachemak Emergency Service Area and is authorized to execute a grant agreement and any other documents deemed necessary to accept and expend the grants and to fulfill the intents and purposes of this ordinance.
