## KENAI PENINSULA BOROUGH ORDINANCE 2007-19-12

## AN ORDINANCE ACCEPTING AND APPROPRIATING \$52,750 FROM THE ALASKA DIVISION OF FORESTRY FOR SPRUCE BARK BEETLE MITIGATION PROGRAM WORK

- WHEREAS, the spruce bark beetle outbreak has affected more than 1.1 million acres within the Kenai Peninsula Borough; and
- WHEREAS, the Kenai Peninsula Borough established the Spruce Bark Beetle (SBB) Mitigation Program in 1999 to implement and administer an action plan for managing the spruce bark beetle outbreak; and
- WHEREAS, in Ordinance 2000-19-19, the Phase II Program Outline and Description governing SBB mitigation programs was enacted; and
- WHEREAS, Ordinance 2004-33, adopted by the KPB Assembly on October 26, 2004, accepted the Interagency All Lands/All Hands Action Plan as the wildfire section of the KPB All-Hazard Mitigation Plan; and
- WHEREAS, the objective of this plan is to support Community Wildfire Protection Plans and interagency actions to continue spruce bark beetle wildfire hazard mitigation work; and
- WHEREAS, the Spruce Bark Beetle Mitigation Program is currently cooperating with Alaska Division of Forestry to complete projects listed in the Community Wildfire Protection Plans;

## NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- **SECTION 1.** That the mayor is authorized to accept a grant in the amount of \$52,750 from the Alaska Division of Forestry to address the projects listed in Community Wildfire Protection Plans.
- SECTION 2. That the funds are appropriated to Account No. 262.21320.08WUI.49999, SBB Technical Assistance Project Account, to continue mitigation activities approved by KPB Ordinance 2000-19-19 and by KPB Ordinance 2004-33.

- **SECTION 3.** That the mayor is authorized to execute all documents deemed necessary to complete this project in accordance with this ordinance.
- **SECTION 4.** That due to the length and nature of this project, the appropriations established through this ordinance shall not lapse at the end of any particular fiscal year.

**SECTION 5.** That this ordinance takes effect immediately upon its enactment.
