**KENAI PENINSULA BOROUGH  
 ORDINANCE 2007-19-13**

**AN ORDINANCE APPROPRIATING \$815,262.83 FROM THE STATE OF ALASKA  
 DIVISION OF EMERGENCY SERVICES TO REIMBURSE THE BOROUGH FOR  
 COSTS INCURRED WHILE RESPONDING TO FLOODING THAT OCCURRED  
 FROM OCTOBER 8, 2006 TO OCTOBER 13, 2006**

**WHEREAS,** the Borough was hit by a number of fall storms during October 2006 causing significant damage in the Borough; and

**WHEREAS,** a disaster was declared by the Borough Mayor on October 9, 2006, by the State of Alaska on October 14, 2006, and signed by the President on December 8, 2006; and

**WHEREAS,** the Borough will incur costs totaling \$815,262.83 in costs associated with responding and recovering from the floods; and

**WHEREAS,** the costs being incurred by the Borough for response and recovery are eligible for reimbursement from FEMA (Federal Emergency Management Agency) through the State of Alaska, Division of Emergency Services;

**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI  
 PENINSULA BOROUGH:**

**SECTION 1.** That the mayor is authorized to accept funds totaling \$815,262.83 from FEMA and the State of Alaska Division of Emergency Services for reimbursement of costs incurred by the Borough in responding to the flood and repairing damaged Borough infrastructure.

**SECTION 2.** That \$628,622.72 in costs incurred by Road Department in response to these storms be appropriated as follows:



Camelot Subdivision repair	260.11251.E3CAM.49999	\$31,017.00
Lowell Pt road repair	260.11251.E3LOW.49999	\$4,200.00

**SECTION 3.** That \$186,640.11 in costs incurred for initial response be appropriated to 260.11251.07FLD.49999.

**SECTION 4.** That the appropriations made in this ordinance shall apply to the fiscal year ending June 30, 2007.

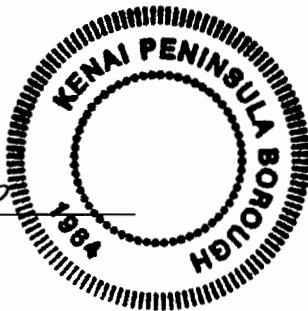
**SECTION 5.** That this ordinance shall be effective upon its enactment.
