## KENAI PENINSULA BOROUGH ORDINANCE 2007-19-14

## AN ORDINANCE ACCEPTING AND APPROPRIATING A STATE GRANT IN THE AMOUNT OF \$35,000 FOR PURCHASE OF A DELIVERY VEHICLE FOR THE NIKISKI SENIOR SERVICE AREA

- WHEREAS, the Nikiski Senior Service Area ("Service Area") has identified the need for a delivery vehicle that will enable it to expand and improve its home delivery meal program; and
- WHEREAS, the Assembly included a request for funding for this project in the Borough's 2007 State Funding Priorities; and
- WHEREAS, Senate Bill 53, which appropriated funding to the Borough for this project, was passed by the State Legislature and signed by the Governor in June 2007; and
- WHEREAS, notice has been received from the Alaska Department of Commerce, Community and Economic Development that a legislative grant has been awarded to the Borough in the amount of \$35,000 for a delivery vehicle for the Service Area; and
- WHEREAS, at its regular meeting on July 10, 2007, the Service Area Board of Directors recommended that the grant be accepted and appropriated;

## NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- SECTION 1. That the mayor is authorized to accept a grant from the Department of Commerce, Community and Economic Development in the amount of \$35,000 to purchase a vehicle for the Service Area, and is authorized to execute a grant agreement and any other documents deemed necessary to accept and expend the grant and to fulfill the intents and purposes of this ordinance.
- **SECTION 2.** That funds in the amount of \$35,000 are appropriated as follows:

\$33,967.00 to account 280.63190.08308.48310 – Vehicles Account \$1,033.00 to account 280.63190.08308.61990 - Administrative service fee

**SECTION 3.** That due to the length and nature of this project, the appropriations established through this ordinance shall not lapse at the end of any particular fiscal year.
