KENAI PENINSULA BOROUGH ORDINANCE 2007-19-19

AN ORDINANCE ACCEPTING AND APPROPRIATING THREE STATE GRANTS TOTALING \$152,500 FOR SCHOOL CAPITAL PROJECTS

- WHEREAS, the Kenai Peninsula Borough School District and the Borough Maintenance Department compiled a list of school capital improvement projects that were included in the Borough's 2007 State Funding Priorities; and
- WHEREAS, Senate Bill 53, which appropriated funding to the Borough for several school projects, was passed by the State Legislature and signed by the Governor in June 2007; and
- WHEREAS, notice has been received from the Alaska Department of Commerce, Community and Economic Development that three legislative grants were awarded to the Borough for school projects, totaling \$152,500; and
- WHEREAS, the performance period for these state legislative grants is from July 1, 2007, through July 1, 2012, and matching funds are not required; and
- WHEREAS, acceptance of these grants will benefit three Kenai Peninsula Borough schools;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

- **SECTION 1.** That the mayor is authorized to accept three grants from the Alaska Department of Community and Economic Development for school-related projects totaling \$152,500, and is authorized to execute grant agreements and any other documents deemed necessary to accept and expend the grants and to fulfill the intents and purposes of this ordinance.
- **SECTION 2.** That grant funds in the amount of \$152,500 are appropriated to school project accounts as follows:

Nikiski High School – Security Project – Grant amount of \$40,000 \$38,820.00 appropriated to project account: 400.71082.08307.49999 (Contingency Account) \$1,180.00 appropriated to account 400.71082.08307.61990 (administrative fee) Soldotna Elementary School - Roof Repair - Grant amount of \$75,000

\$72,787.00 appropriated to project account: 400.76010.08309.49999 (Contingency account)

\$2,213.00 appropriated to account 400.76010.08309.61990 (administrative fee)

Soldotna Middle School - Gym Siding - Grant amount of \$37,500

\$ 36,394.00 appropriated to project account: 400.76030.08311.49999 (Contingency Account)

\$1,106.00 appropriated to account 400.76030.08311.61990 (administrative fee)

SECTION 3. That due to the length and nature of these projects, the appropriations established through this ordinance shall not lapse at the end of any particular fiscal year.

SECTION 4. This ordinance shall become effective immediately upon its enactment.
