KENAI PENINSULA BOROUGH ORDINANCE 2007-19-20

AN ORDINANCE ACCEPTING AND APPROPRIATING FOUR STATE GRANTS TOTALING \$1,075,000 FOR CAPITAL IMPROVEMENT PROJECTS FOR THE ROAD SERVICE AREA

- WHEREAS, through enactment of RSA Resolution 2006-16, the Kenai Peninsula Borough Road Service Area compiled a list of road capital improvement projects that were included in the Borough's 2007 State Funding Priorities; and
- WHEREAS, RSA Resolution 2006-16 recommended that Bastein Drive in Nikiski, Community College Drive in Soldotna, Midway Drive in Sterling, and other roads be included in the 2007 Legislative Priorities; and
- WHEREAS, Senate Bill 53, which appropriated funding to the borough for three road projects and borough-wide road improvements, was passed by the State Legislature and signed by the Governor in June 2007; and
- WHEREAS, notice has been received from the Alaska Department of Commerce, Community and Economic Development that three legislative grants have been awarded to the Borough for road projects, totaling \$1,075,000; and
- WHEREAS, at its meeting on August 14, 2007, the Road Service Area Board adopted Resolution 2007-08 and recommended that the Assembly approve acceptance of the four grants; and
- WHEREAS, acceptance of these grants will give the Road Service Area the opportunity to provide better roads for its residents;

NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:

SECTION 1. That the mayor is authorized to accept four grants from the Alaska Department of Commerce, Community and Economic Development for road capital improvement projects totaling \$1,075,000, and is authorized to execute grant agreements and any other documents deemed necessary to accept and expend the grants and to fulfill the intents and purposes of this ordinance.

- **SECTION 2.** That grant funds in the amount of \$1,075,000 are appropriated to road capital project accounts as follows for the listed purposes:
 - Bastein Drive road improvement Grant amount of \$300,000 \$291,149 appropriated to project account: 434.33950.08301.49999 (Contingency account)

\$8,851 appropriated to account 434.33950.08301.61990 (administrative fee)

Community College Drive – paving – Grant amount of \$250,000 \$242,624 appropriated to project account: 434.33950.08304.49999 (Contingency

Account)

\$7.376 appropriated to account 434.33950.08304.61990 (administrative fee)

Midway Drive – road improvement – Grant amount of \$275,000

\$266,887 appropriated to project account: 434.33950.08305.49999 (Contingency Account)

\$8,113 appropriated to account 434.33950.08305.61990 (administrative fee)

Borough-wide road improvements – Grant amount of \$250,000

\$242,624 appropriated to account 434.33950.08302.49999 (unallocated road projects)

\$7,376 appropriated to account 434.33950.08302.61990 (administrative fee)

- **SECTION 3.** Acceptance of the above grants is subject to the requirement that the award of a contract for each project shall be submitted to the Assembly for approval by resolution. No contract may be awarded until after the grant agreement for these funds has been executed by the Borough and the State.
- **SECTION 4.** That due to the length and nature of this project, the appropriation established through this ordinance shall not lapse at the end of any particular fiscal year.

SECTION 5. This ordinance shall become effective immediately upon enactment.
