## **AGREEMENT**

The Alaska Department of Commerce, Community and Economic Development, Division of Community Advocacy (hereinafter 'Department') and **Kenai Peninsula Borough** (hereinafter 'Grantee') agree as set forth herein.

Section I. The Department shall pay the Grantee for the performance of the project work under the terms outlined in this agreement. The amount of the payment is based upon project expenses incurred, which are authorized under this Agreement. In no event shall the payment exceed \$38,500. The required match contribution is to be not less than 50% of the grant award.

Section II. The Grantee shall perform all of the work required by this Agreement.
