**KENAI PENINSULA BOROUGH  
ORDINANCE 2007-19- 24**

**AN ORDINANCE ACCEPTING A \$38,500 GRANT FROM THE STATE OF ALASKA  
FOR THE BOROUGH'S COASTAL ZONE MANAGEMENT PROGRAM**

**WHEREAS,** the Kenai Peninsula Borough Coastal Zone Management Program provides coordinated planning and consistency reviews for Section 306 (16 U.S.C § 1455) funding under the Alaska Coastal Management Program; and

**WHEREAS,** the Alaska Department of Community and Economic Development has approved the Borough's request for Section 306 funding under the Alaska Coastal Management Program; and

**WHEREAS,** the Borough has received notice of award of a grant in the amount of \$38,500 for use in administration and implementation of the Borough's Coastal Zone Management Program; and

**WHEREAS,** the Section 306 grant program requires a local match in the amount of 50 percent (\$19,250); and

**WHEREAS,** sufficient funds are included in the approved FY 2008 budget for Coastal Zone Management to meet the grant's local match requirement of \$19,250;

**NOW, THEREFORE, BE IT ORDAINED BY THE ASSEMBLY OF THE KENAI PENINSULA BOROUGH:**

**SECTION 1.** That the mayor is authorized to accept a grant from the State of Alaska, Department of Community and Economic Development, in the amount of \$38,500 for administration and implementation of the Borough's Coastal Zone Management Program.


**SECTION 2.** That the mayor is authorized to execute a grant agreement and any other documents deemed necessary to accept and expend the grant and to fulfill the intents and purposes of this ordinance.

**SECTION 3.** That the sum of \$38,500 is hereby appropriated to the following accounts:

\$36,290 to account 257.22410.21882.40xxx – salary and benefits  
\$1,975 to account 257.22140.21882.43210 – travel  
\$235 to account 257.22140.21882.42110 – office supplies


**SECTION 4.** This ordinance shall become effective immediately upon its enactment.

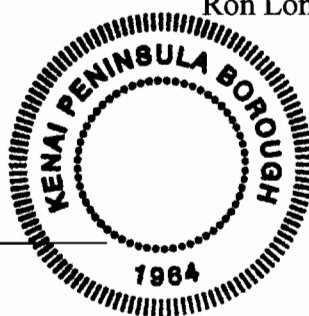
