The Alaska Division of Homeland Security and Emergency Management (DHS&EM) is pleased to award the Kenai Peninsula Borough the amount of \$30,712.00 under the 2007 Citizen Corps Program for the performance period of October 1, 2007 through September 30, 2009.

Funding from this program is provided to enhance the ability of states, territories, and urban areas to prepare for, prevent, and respond to terrorist attacks and other all-hazards events.

This year, as promised, local jurisdictions historical grant performance was a part of the scoring considered during the 2007 Homeland Security grant review process. DHS&EM staff performed an analysis over an 18-month period of grant performance in 10 areas. The Kenai Peninsula Borough scored 70 out of a potential 100, in overall grant performance.

A voluntary interagency review committee comprised of five representatives from three State agencies met on August 21st to review eligible projects, prior jurisdictional grant performance, and determine award allocation amounts. The recommendation from this review committee was presented to the State Emergency Response Commission (SERC) Finance Committee for their review and final approval. The result of these two reviews is reflected in the allocated funds identified in the project budget detail attached with the award document.


